Exclusion - Waste conditions

Clause 7 - Exclusions to insured section B, C, D and E

The following clause is added to clause 7 of this **policy**.

Insured sections B, C, D and E exclude and do not cover the **insured** in respect of any liability arising out of or in any way connected with the ownership management or operation of landfill sites and/or incineration plants.

Clause 7 - Exclusions to insured sections B, C, D and E

The following clause is incorporated in and forms part of clause 7 to this **policy**.

Insured sections B, C, D and E exclude and do not cover **bodily injury, personal injury, damage or denial of access** caused by or arising from or in connection with the operation and/or ownership of landfill sites.
